EXHIBITOR RULES & REGULATIONS APPLIES TO MEMBERS/NON-MEMBERS ALIKE

- 1. All art and crafts must be created by the seller, and must be in good taste. A craft must contain 80% of the member's work to be considered appropriate for display at this event. NO RESALE ITEMS or items made by any one other than the exhibitor may be displayed for sale.
- 2. The Lakewood Artist guild reserves the right to request the removal of any product that does not meet this requirement. If you didn't make it- don't bring it!
- 3. Space size will be approximately 10' x10'—no electricity available.
- 4. Each exhibitor must provide their own displays—canopy, tables, and etc.
- 5. All exhibitors are to remain open for the entire show unless other arrangements have been made.
- 6. Fiesta will be held rain or shine-no relocation. No refunds after April 10, 2009
- 7. A Valid Resale Certificate must be on display in each booth. Temporary certificates are available from the Franchise Tax Board. Receipts must be given for sales.
- 8. Sharing of spaces is permitted provided all persons complete and sign an application.
- 9. Check in & unloading times: 7:30 a.m. to 10 a.m. Your space will be reassigned to another vendor if you have not check in on time and could result in your being disallowed from the show.
- 10. Exhibits must be set up and taken down each day. There is no storage available.
- 11. Items are to be unloaded at the curb, and your vehicle must be moved to a side street PRIOR to setting up your space.
- 12. No edible, live floral, or animal, or flammable products may be offered for sale.
- 13. Current dues and membership application must be on file prior to set up to be considered an active member of Lag. NO DOGS ALLOWED AT LAKEWOOD PARKS.

I WILL SUPPORT THE AIMS AND PURPOSE OF THE LAKEWOOD ARTIST GUILD, A NON-PROFIT CORPORATION FOR THE ADVANCEMENT OF THE ARTS.
